Add Evaluation committee:(Previously approved amendment 2017- needs to be added to by laws document)

Include **By-Laws: Scholarship Program Changes May 12, 2017**, (Amendment adopted in 2017-needs to be added to by laws document)

Section 1 – Change to:

One \$500.00 scholarship given in memory of Charles J. Jaworek (first granted in 1947) will be granted by the Association yearly. The decision will be based upon review of the completed application, Marlborough High transcript, letter of recommendation, and extracurricular, volunteer, community service work, or employment. This scholarship will be titled: "Marlborough Educators Association, Inc. Scholarship. Given in Memory of Charles W. Jaworek." This award will only be granted to a Marlborough High School graduate.

Section 2 – Change to:

Based upon available funds, additional scholarships will be granted to remaining applicants, with each award amount being divided equally among recipients. These scholarships will be titled "Marlborough Educators Association, Inc. Scholarship." The recipient must be a graduate of a high school.

Section 3 Changes to:

A. Applicants will apply for scholarship consideration on the approved form developed by the Association and made available through the Marlborough High School Guidance Department, MEA Faculty Representatives, or through the MEA website.

B. Applicants must have applied for enrollment in a four or more year accredited degree granting college or university, and must have said application already accepted.
